




□INSERTION LOSS

□RETURN LOSS

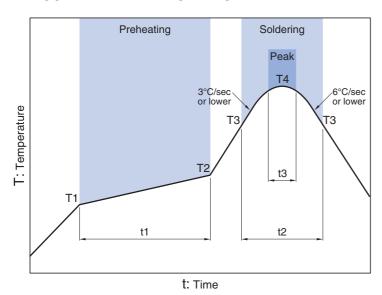
