Typical Insertion Loss:



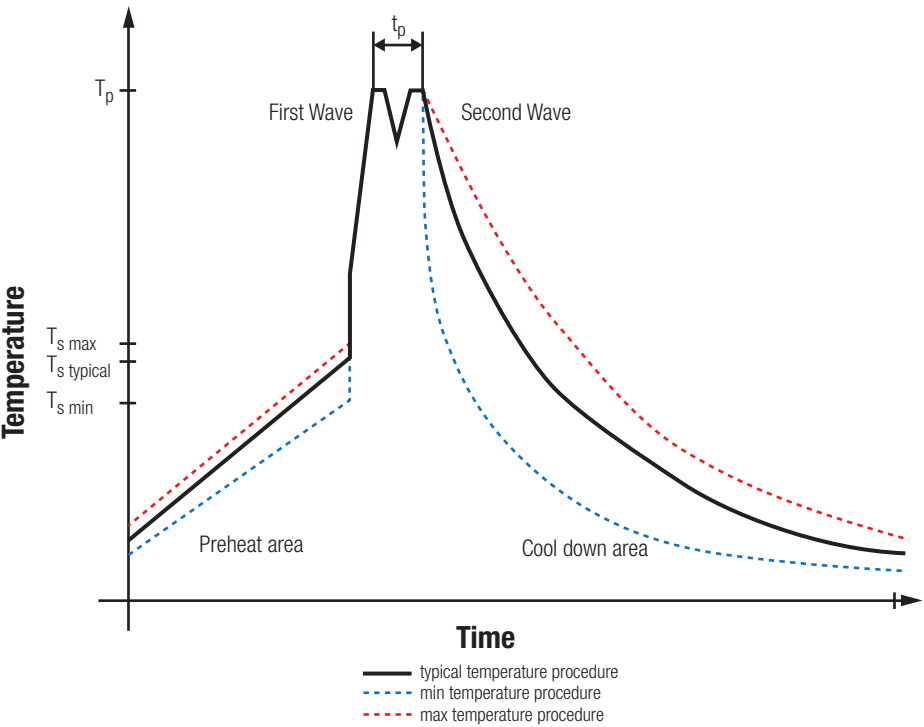




