Cleaning and Washing:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire
insulation, the marking or the plating. The washing agent could have a negative effect on the long term functionality of the product.

Storage Conditions:

- Limiting factors for the storage stability of electronic components are material characteristics and a solderability decrease of the terminations. Therefore all products shall be used within the period of 12 month based on the day of shipment.
- Do not expose the components into direct sunlight.

• The storage condition in the original packaging refered to DIN EN 61760-2.


Potting:
