100 mm Length of Travel Lever End Style "A"



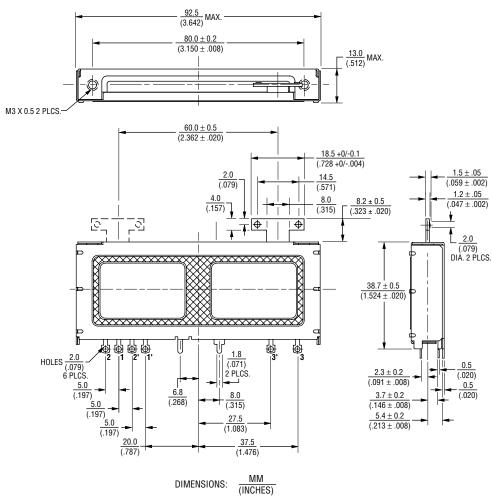
45 mm Length of Travel Lever End Style "T"



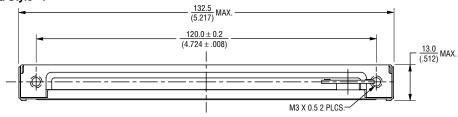


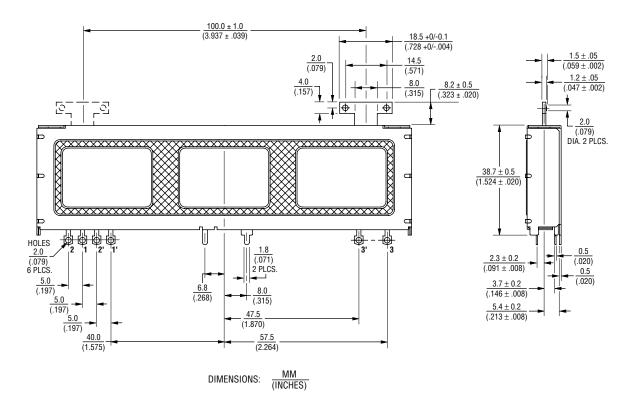
