













SOLDER LUG TERMINALS MODEL 53



ELECTRICAL SCHEMATIC




ANTI-ROTATION LUG (Style "A" Shown)




MM DIMENSIONS: (INCHES)

SHAFT FLAT ORIENTATION




SUGGESTED PANEL LAYOUT


