The TC74ACT04 is an advanced high speed CMOS INVERTER fabricated with silicon gate and double-layer metal wiring  $C^2MOS$  technology.


It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.

This device may be used as a level converter for interfacing TTL or NMOS to High Speed CMOS. The inputs are compatible with TTL, NMOS and CMOS output voltage levels.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.
