




Figure 17. Common Emitter Characteristics




Figure 19. Common Emitter Characteristics





Figure 18. Common Emitter Characteristics




Figure 21. 6-LEAD, SUPERSOT-6, JEDEC MO-193, 1.6 MM WIDE (ACTIVE)




Figure 22. 16-LEAD, SOIC, JEDEC MS-012, 0.150 inch, NARROW BODY (ACTIVE)
