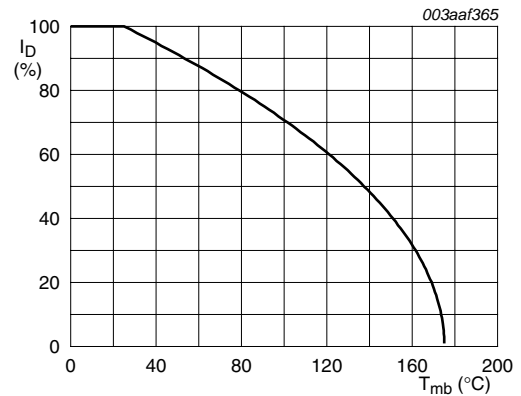

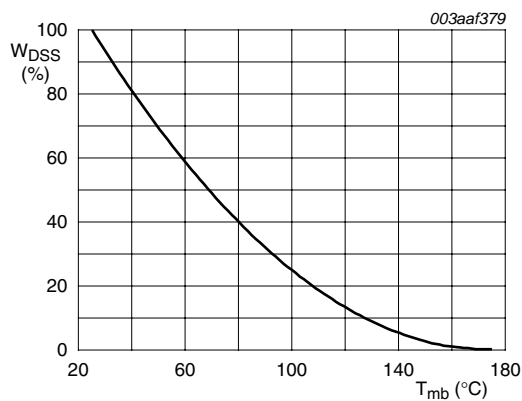
**Fig 1. Normalized total power dissipation as a function of mounting base temperature**

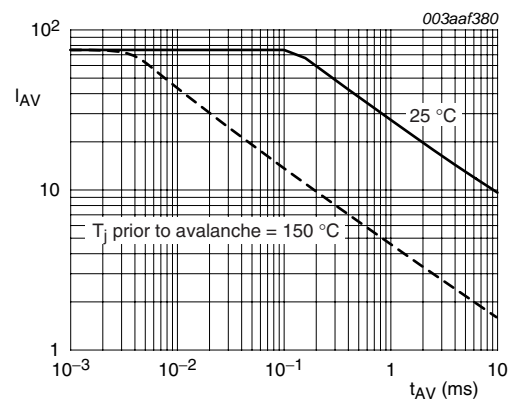

**Fig 2. Normalized continuous drain current as a function of mounting base temperature**



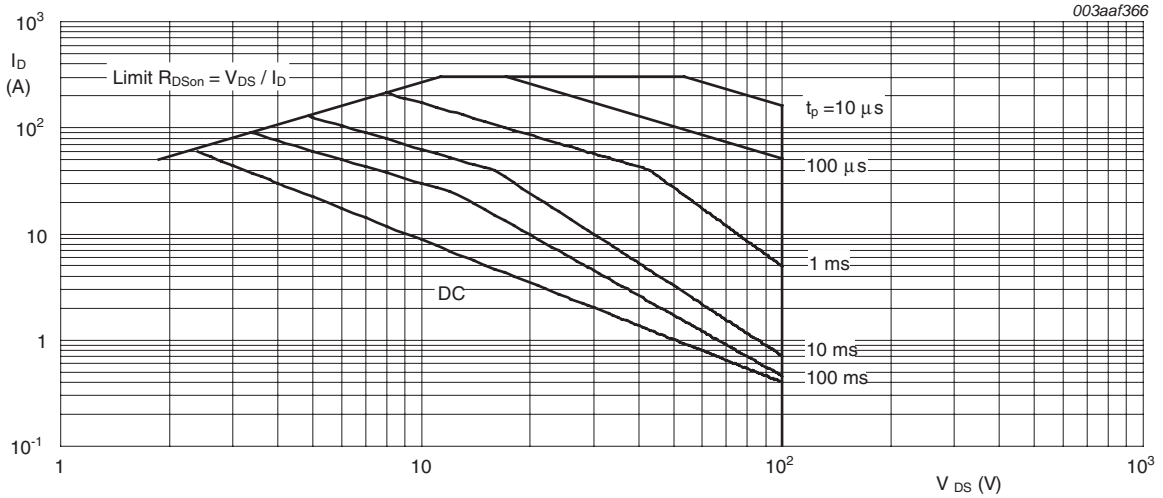

**Fig 4. Single-shot avalanche rating; avalanche current as a function of avalanche period**



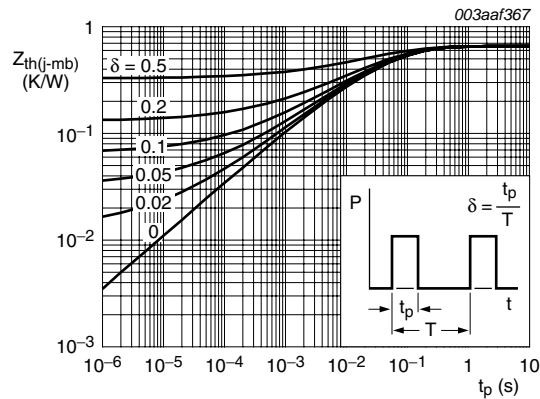

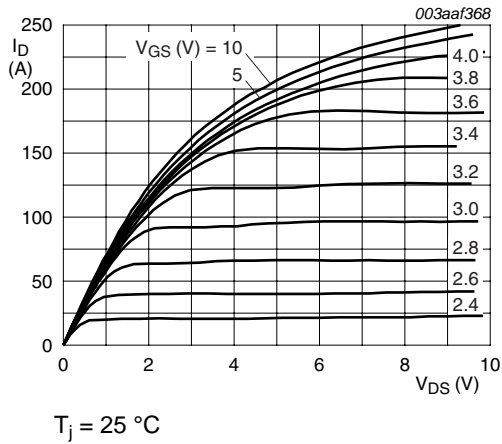


**Fig 6. Transient thermal impedance from junction to mounting base as a function of pulse duration**

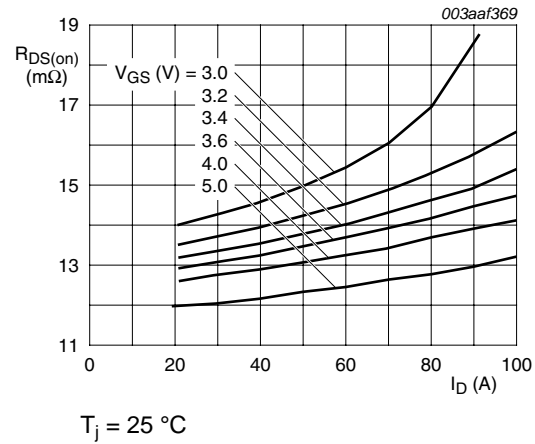

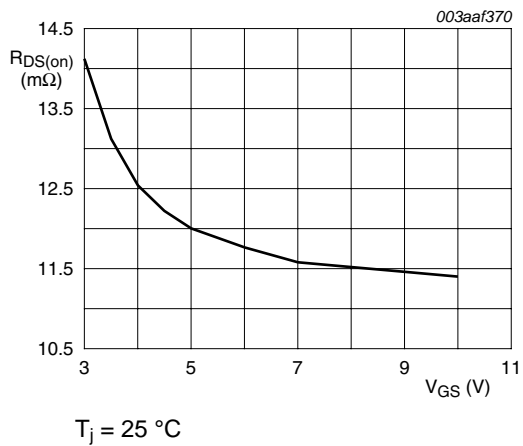

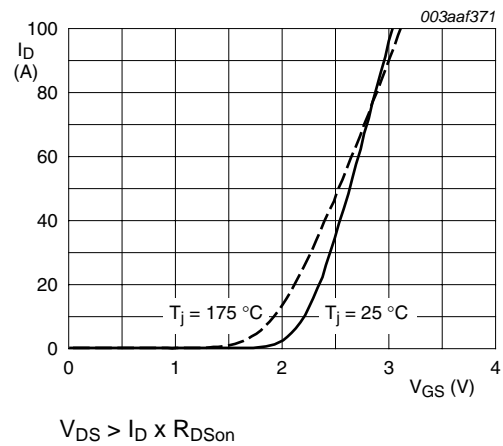
**Fig 7. Output characteristics: drain current as a function of drain-source voltage; typical values**



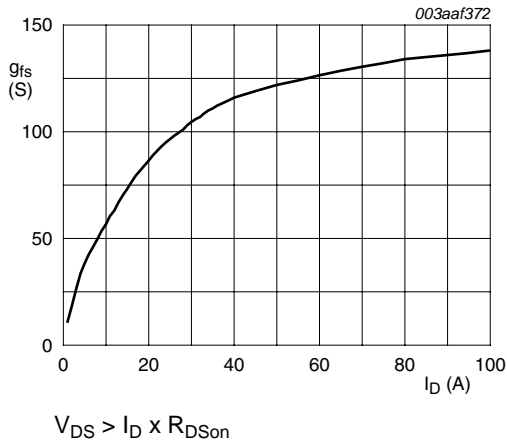
**Fig 8. Drain-source on-state resistance as a function of drain current; typical values**



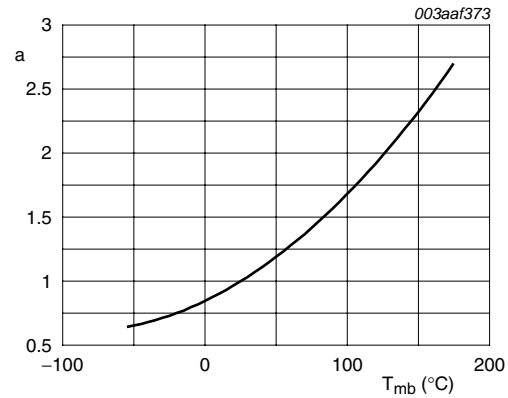
**Fig 9. Drain-source on-state resistance as a function of gate-source voltage; typical values**



**Fig 10. Transfer characteristics: drain current as a function of gate-source voltage; typical values**



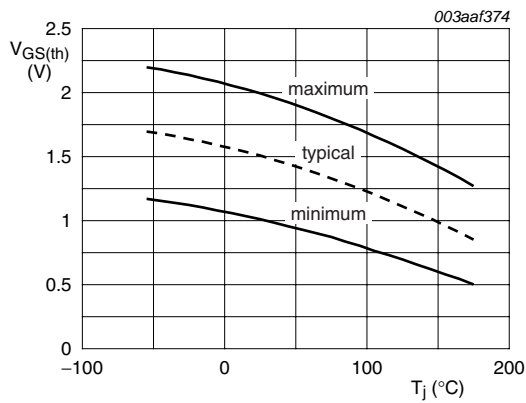
**Fig 11. Forward transconductance as a function of drain current; typical values**



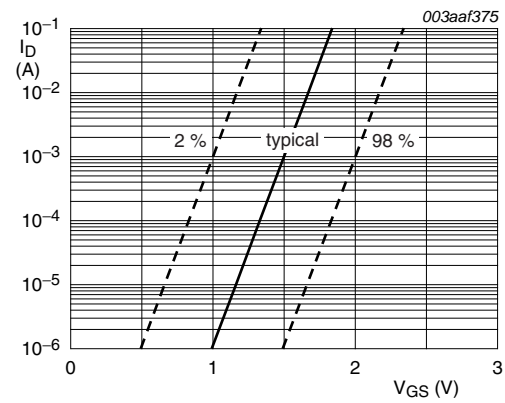

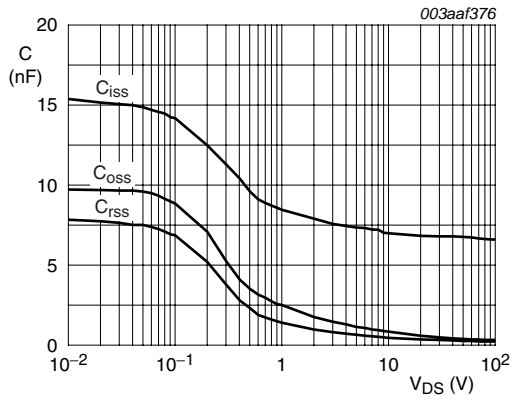
**Fig 12. Normalized drain-source on-state resistance factor as a function of junction temperature**



**Fig 13. Gate-source threshold voltage as a function of junction temperature**

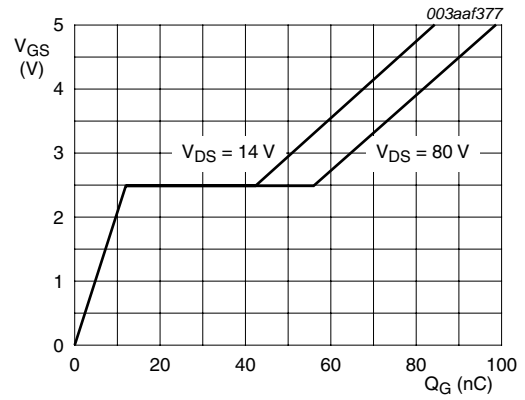


**Fig 14. Sub-threshold drain current as a function of gate-source voltage**
