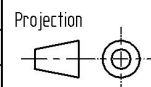
E General information:

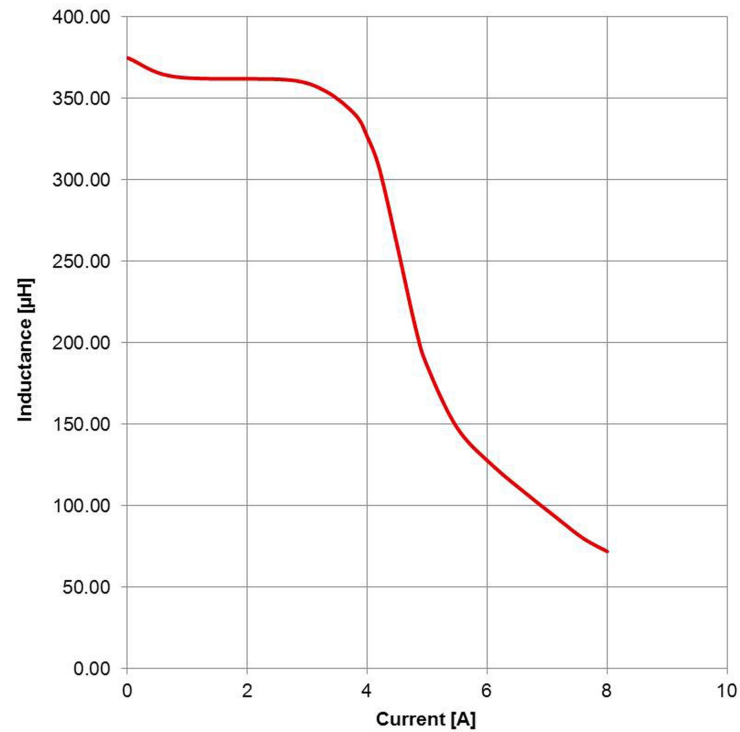
