Luminous Intensity vs. Forward Current:



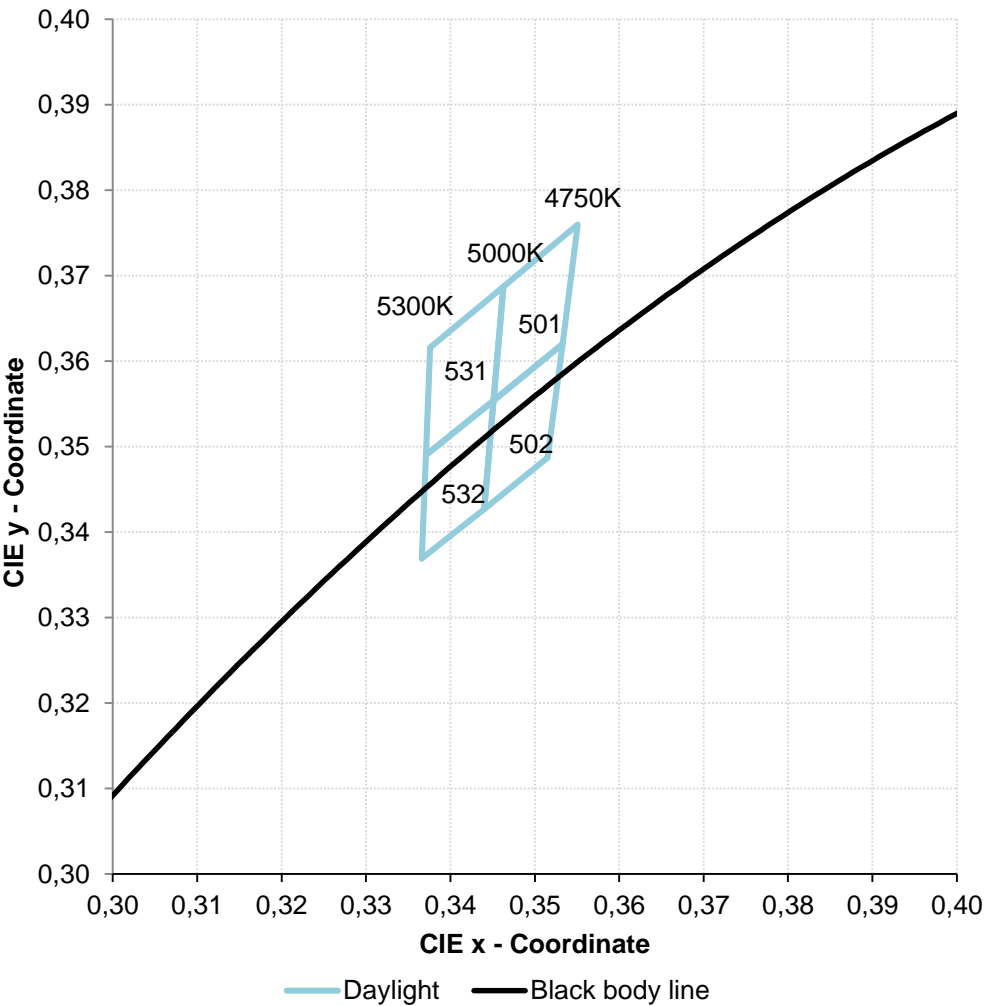

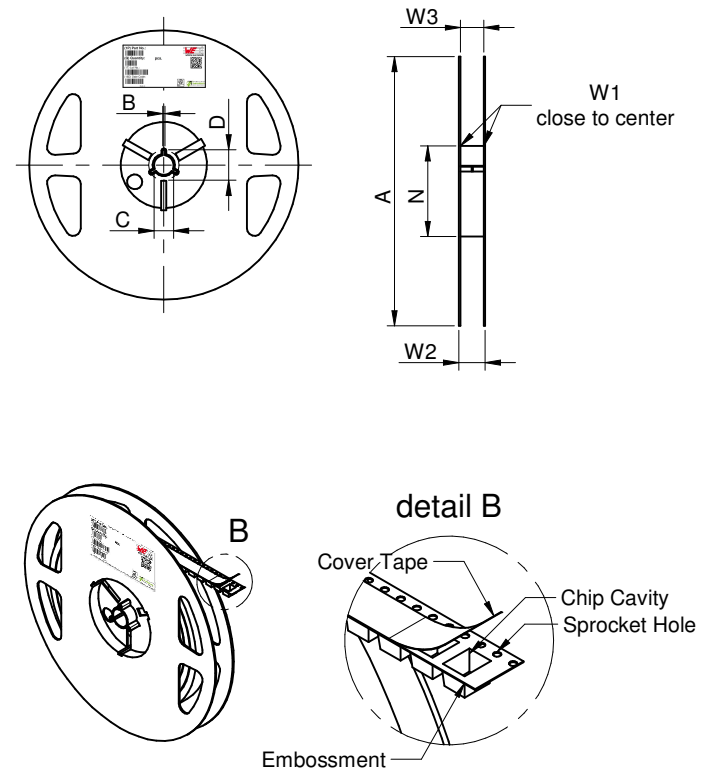
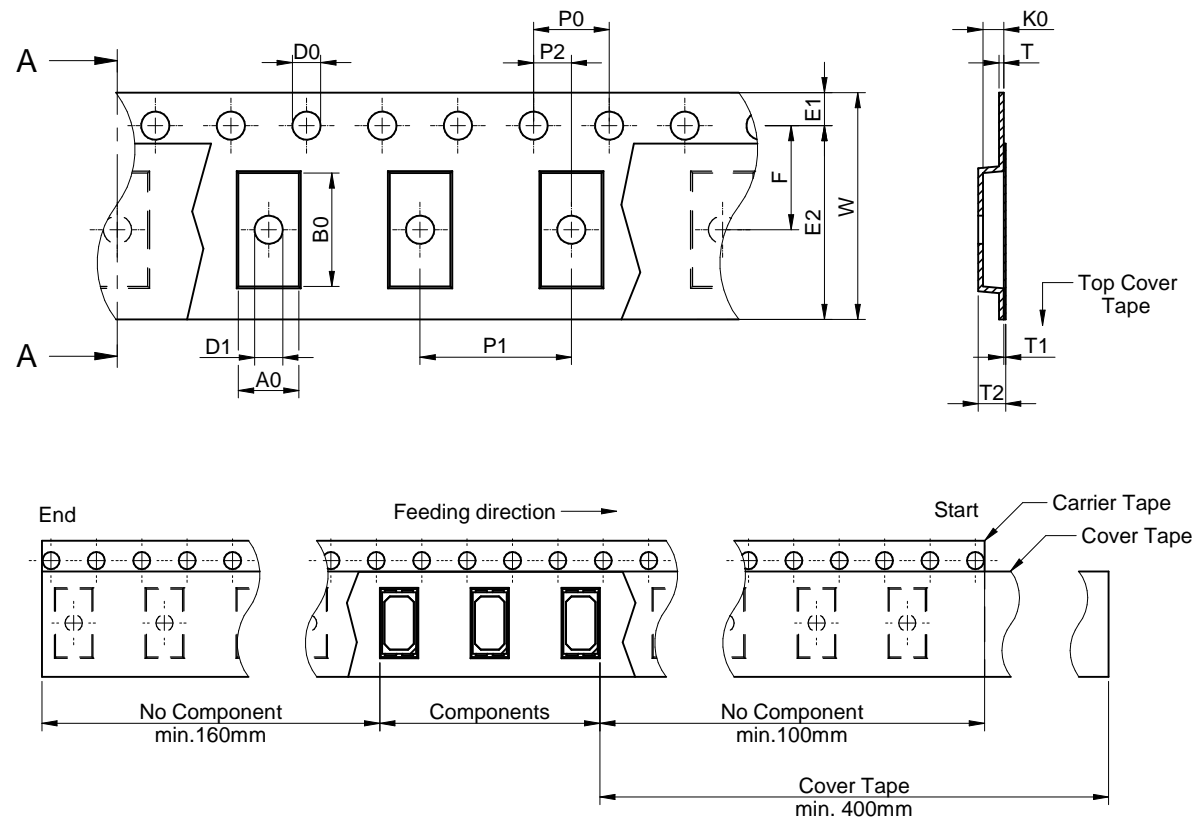
Chromaticity diagram:

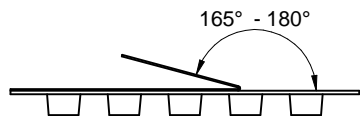



Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.



Handling:


