





■ FREQUENCY CHARACTERISTICS


□INSERTION LOSS

□RETURN LOSS

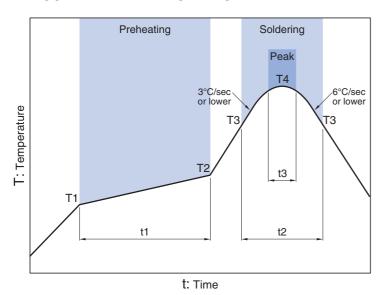
