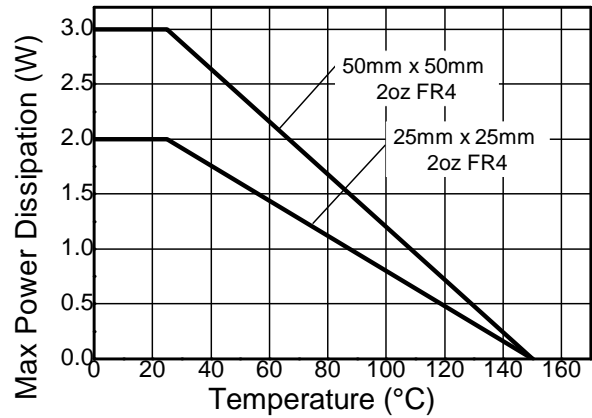
**Transient Thermal Impedance**

**Pulse Power Dissipation**



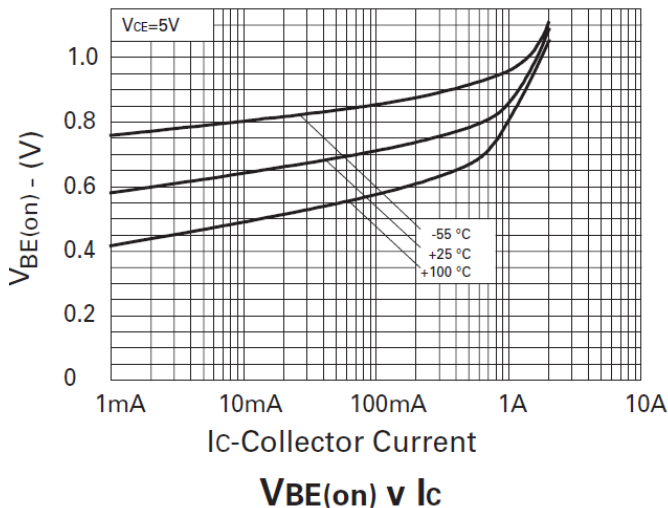
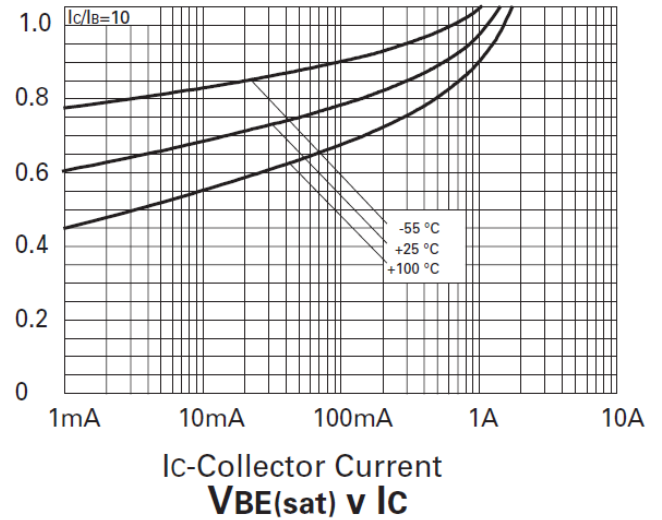
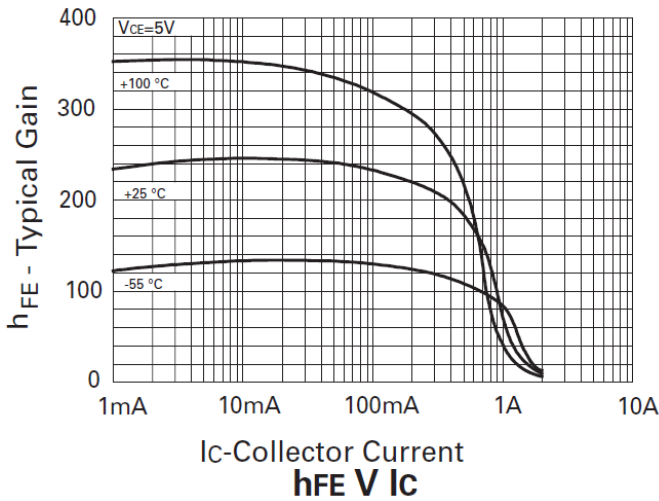
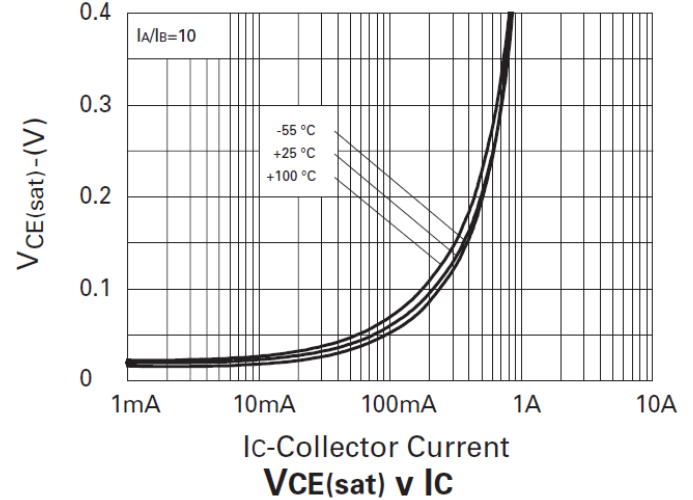
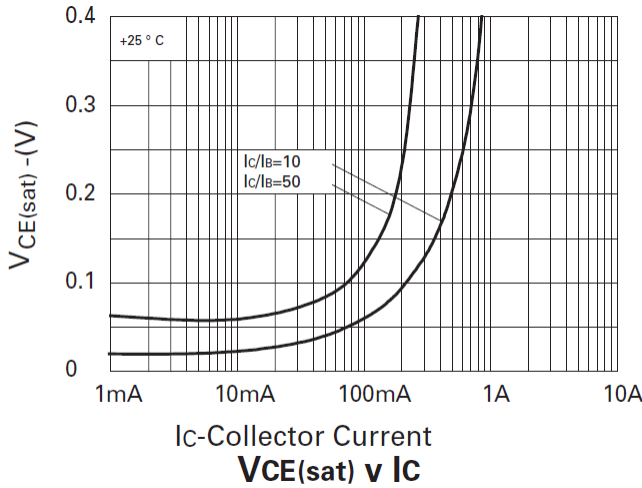
