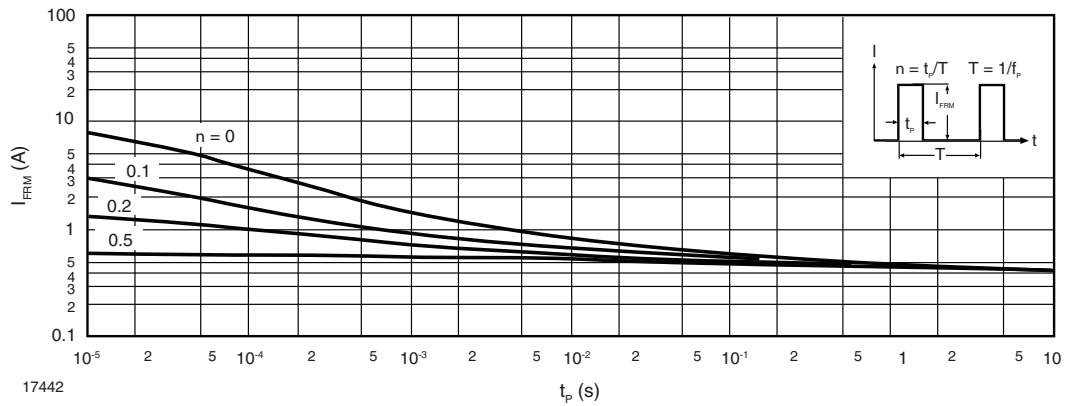


Fig. 6 - Admissible Repetitive Peak Forward Current vs. Pulse Duration
