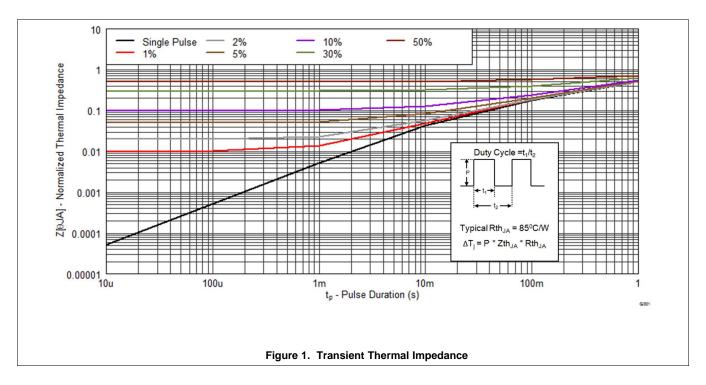

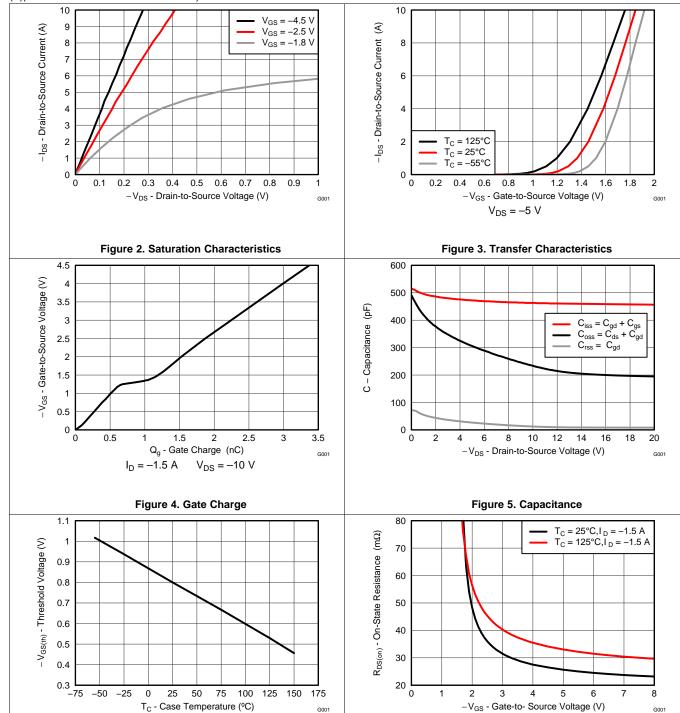


Figure 6. Threshold Voltage vs Temperature

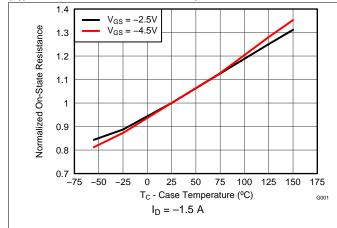

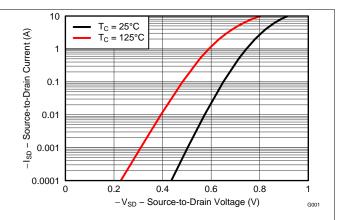
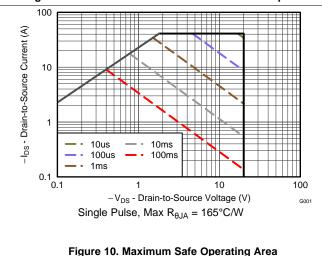


Figure 8. Normalized On-State Resistance vs Temperature





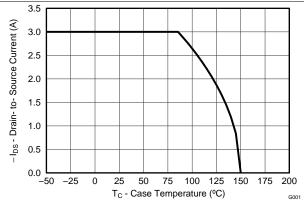


Figure 11. Maximum Drain Current vs Temperature
