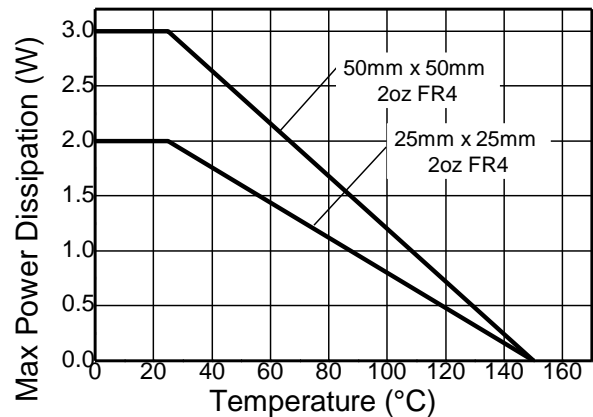
Transient Thermal Impedance

Pulse Power Dissipation



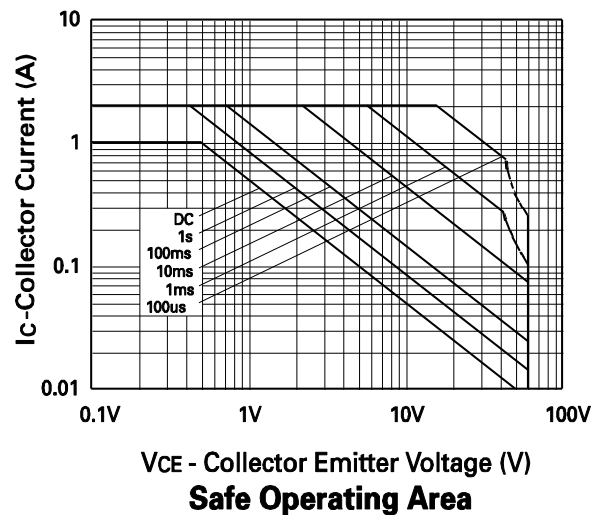
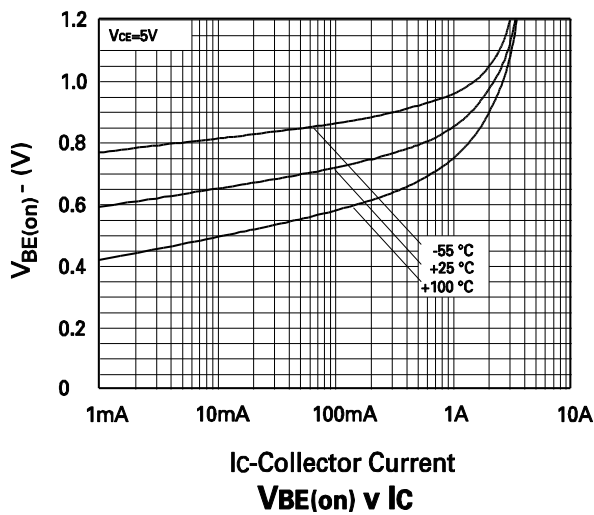
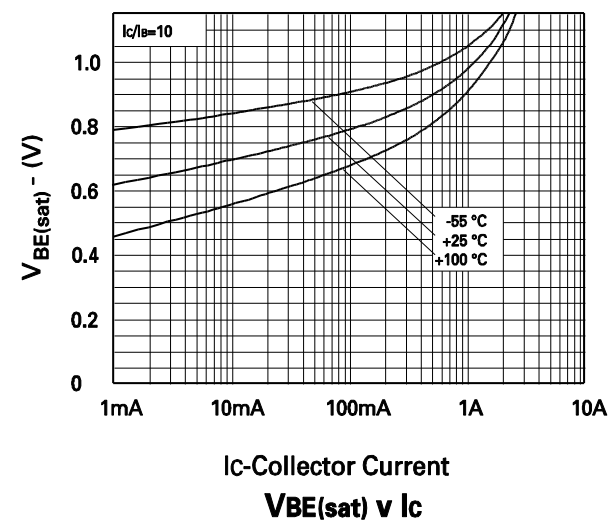
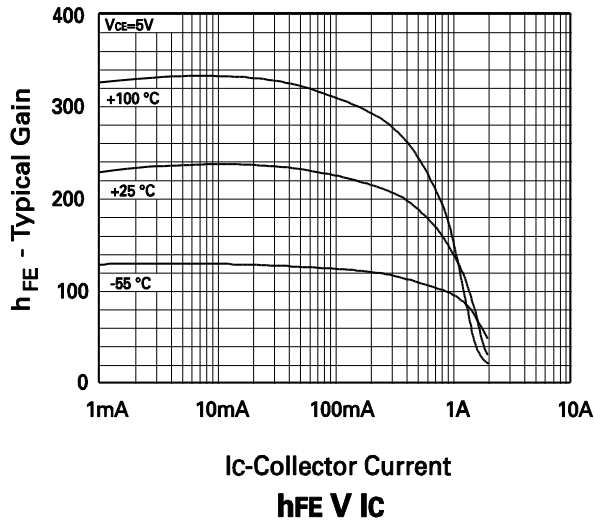
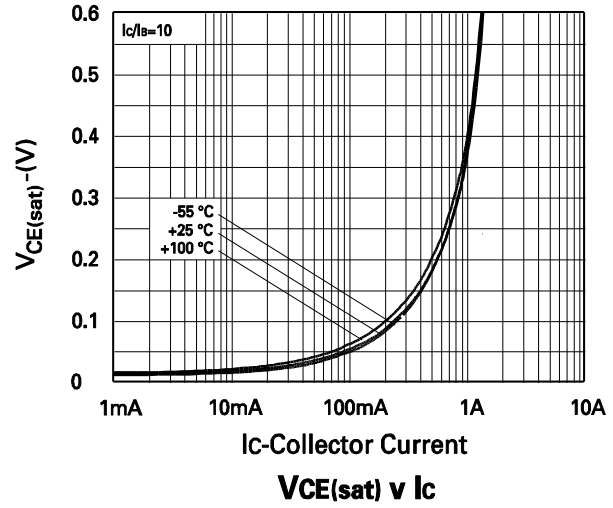
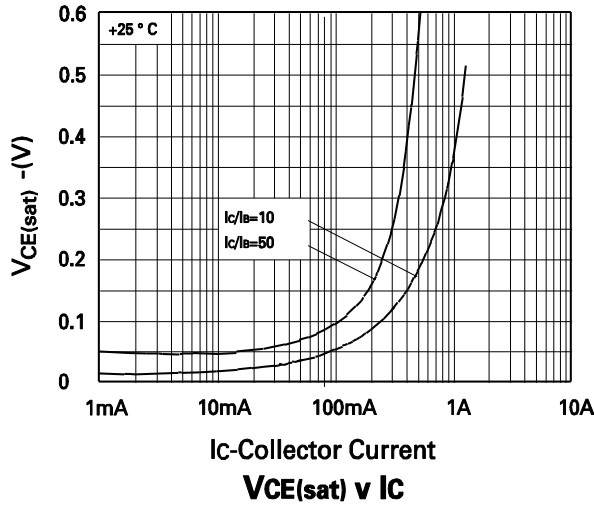

Package Outline Dimensions

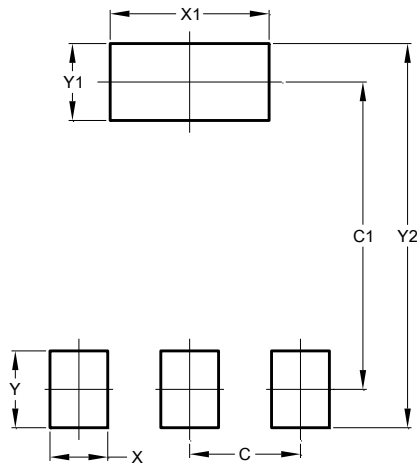
