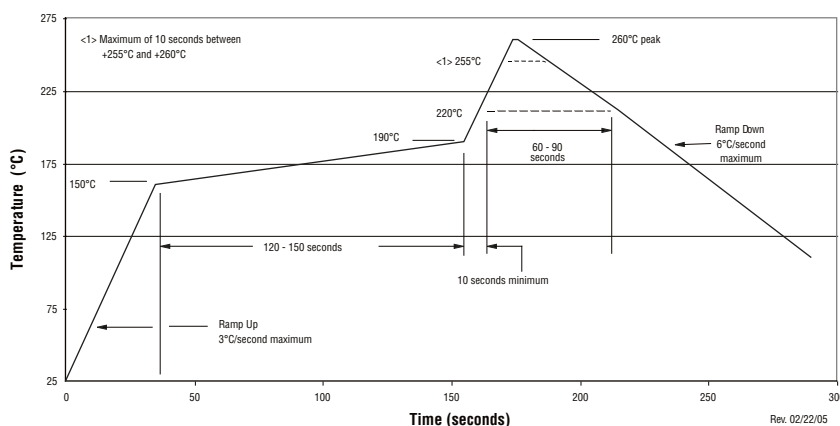

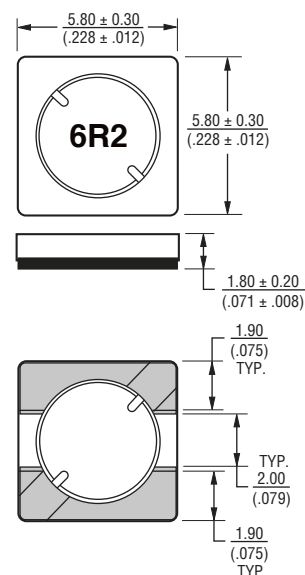

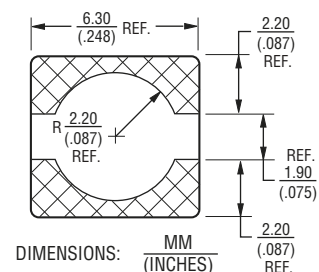

Recommended Layout



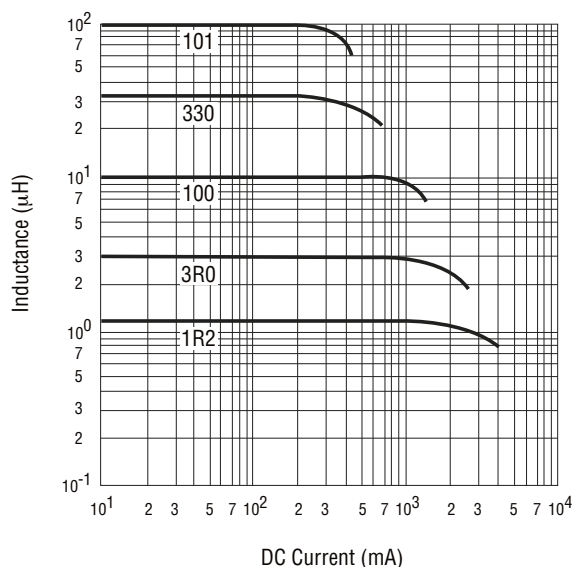

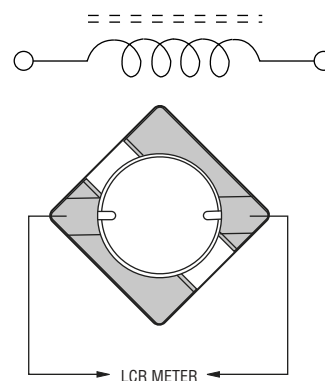

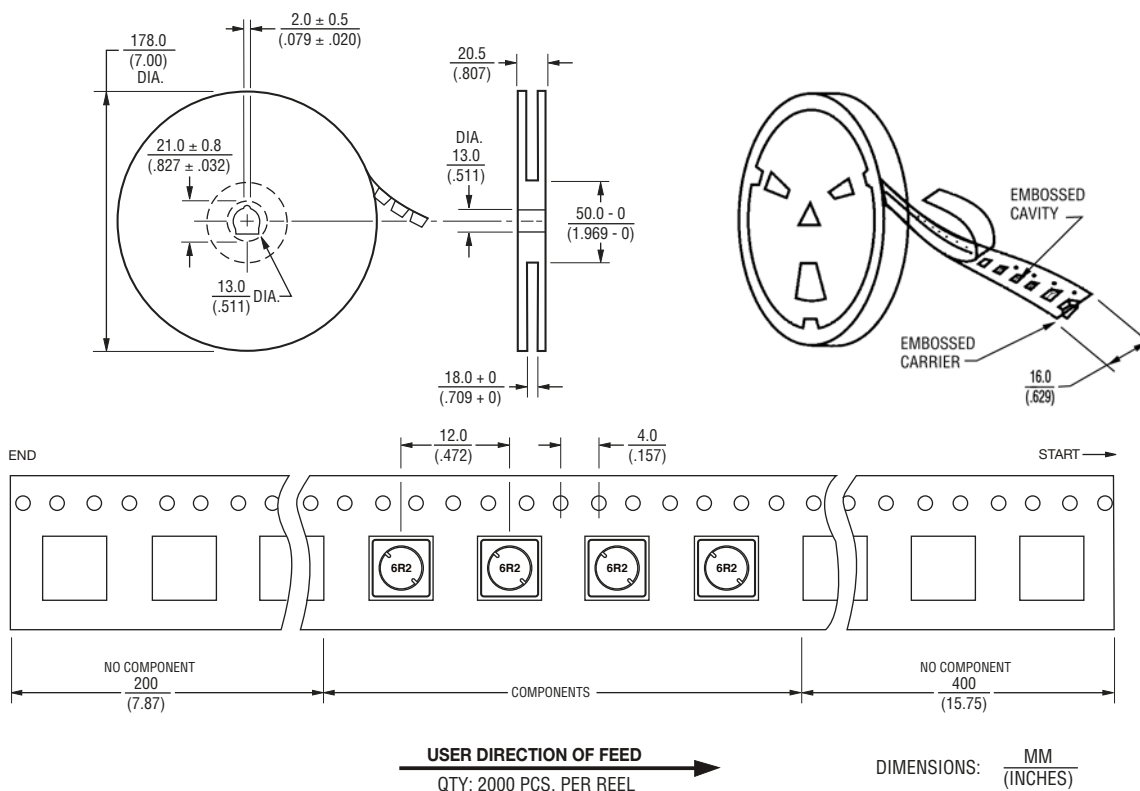
Inductance vs. Current
