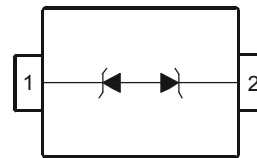

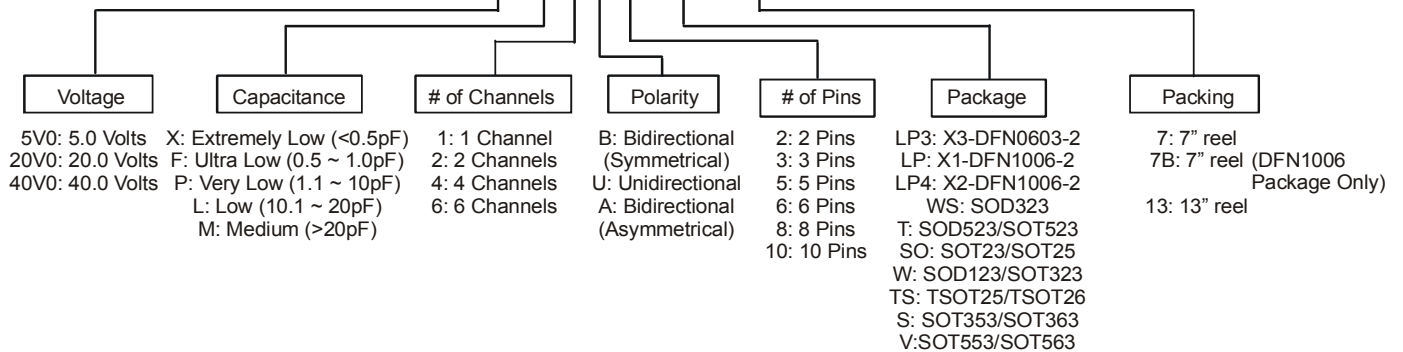
Top View

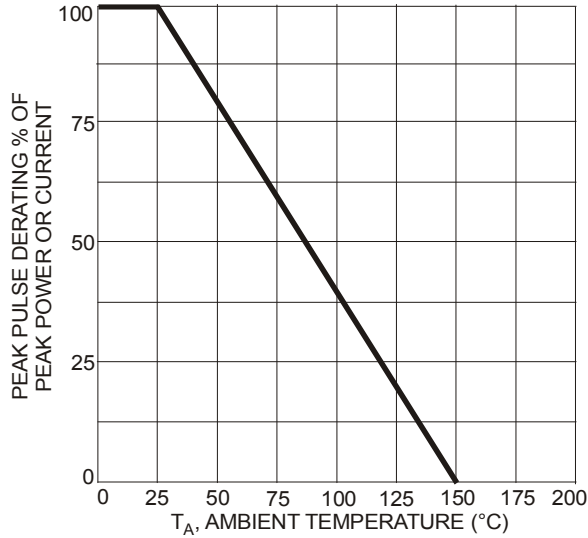


Figure 3 Power Dissipation vs. Ambient Temperature

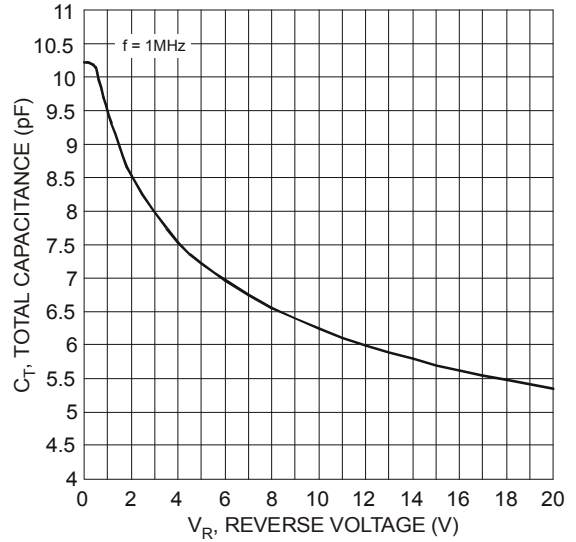


Figure 4 Typical Total Capacitance vs. Reverse Voltage

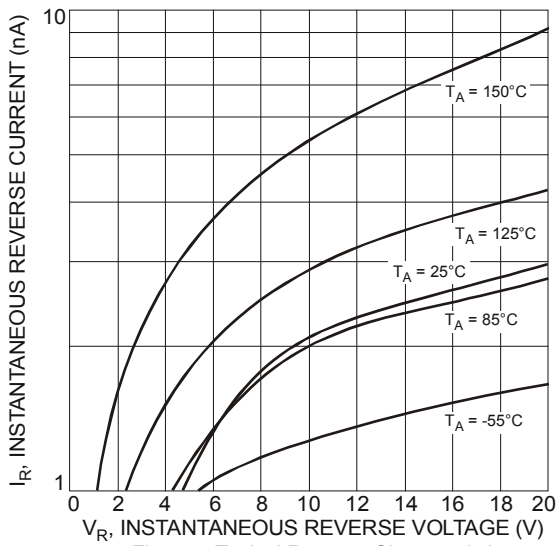
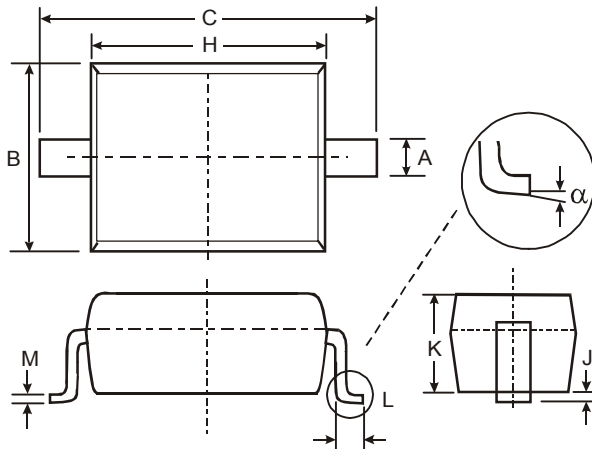


Figure 5 Typical Reverse Characteristics

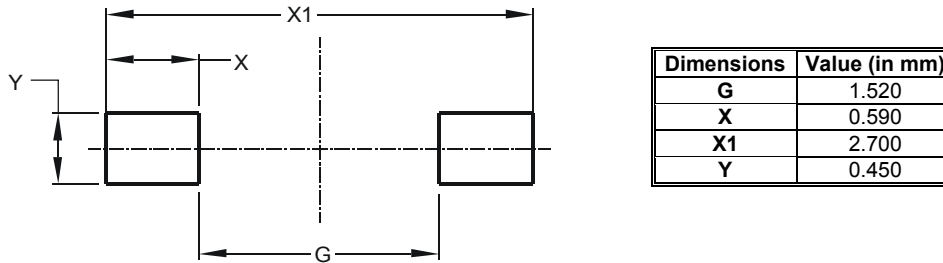
