### Typical Impedance Characteristics:



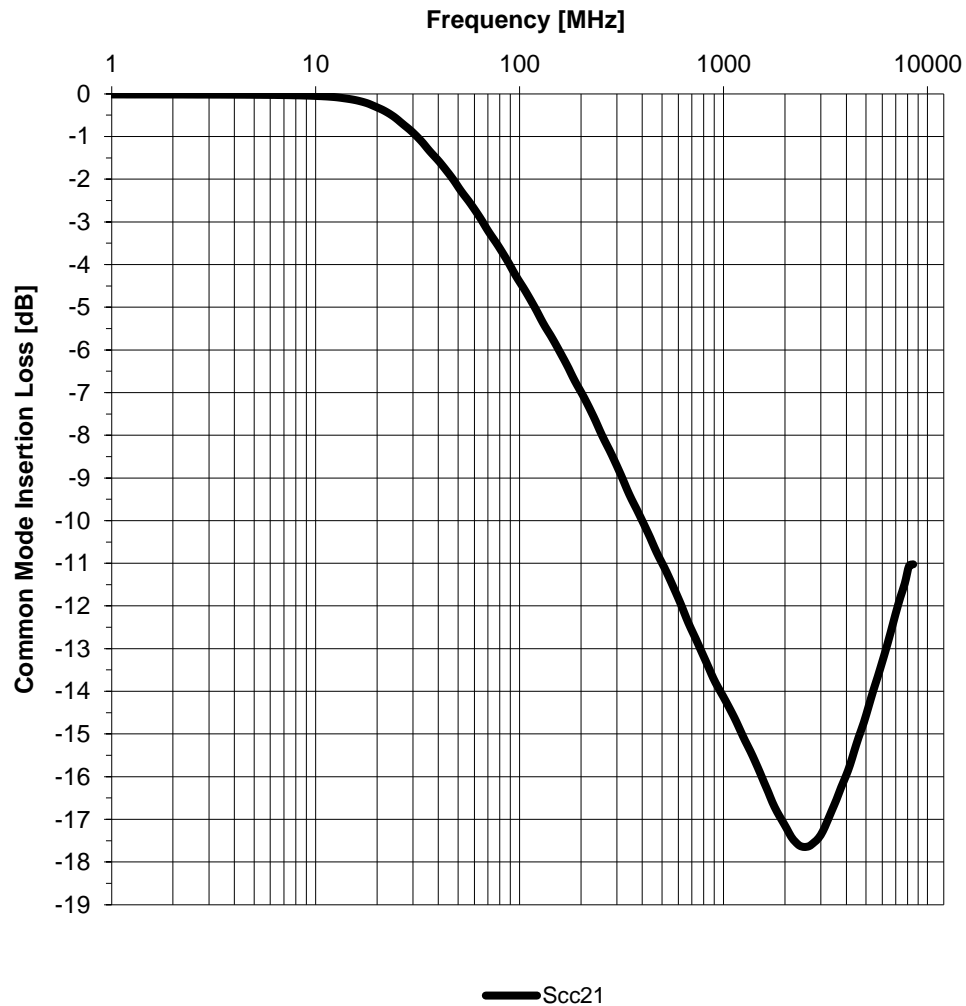
### Typical Differential Mode Insertion Loss Characteristics:



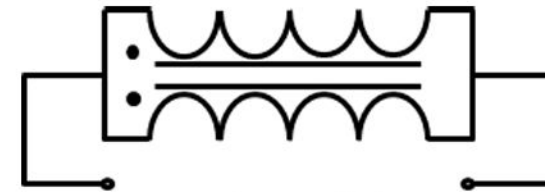

Differential Mode

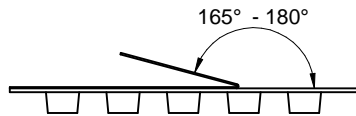

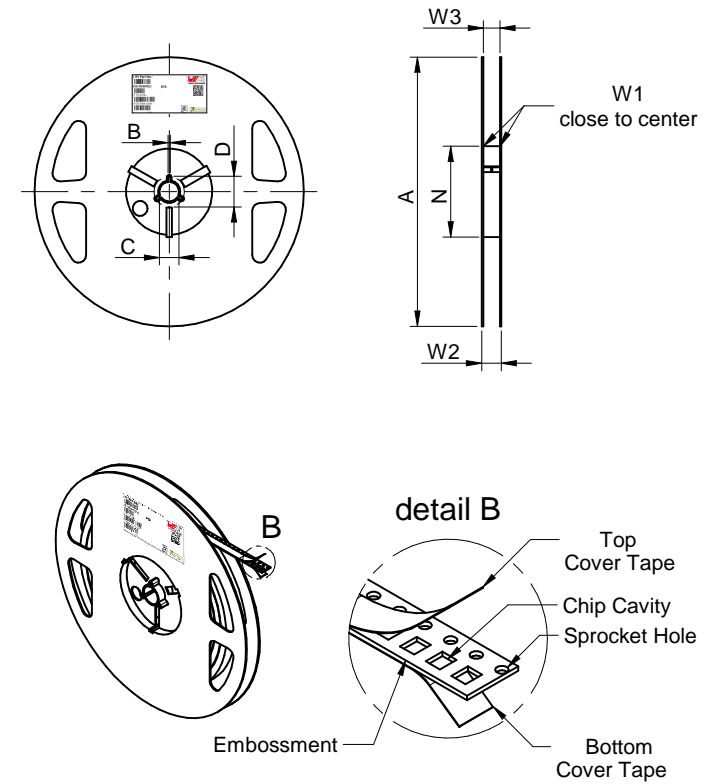



#### Storage Conditions:


