




Fig. 1 - Maximum Forward Voltage Drop Characteristics




Fig. 2 - Typical Peak Reverse Current vs. Reverse Voltage






Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage



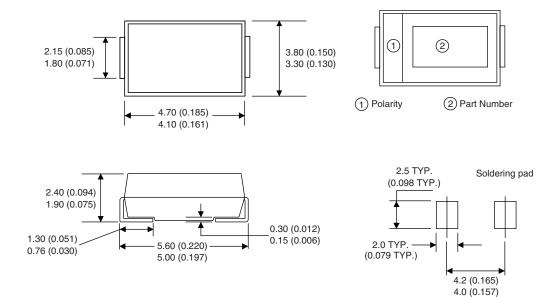
