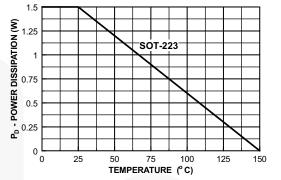
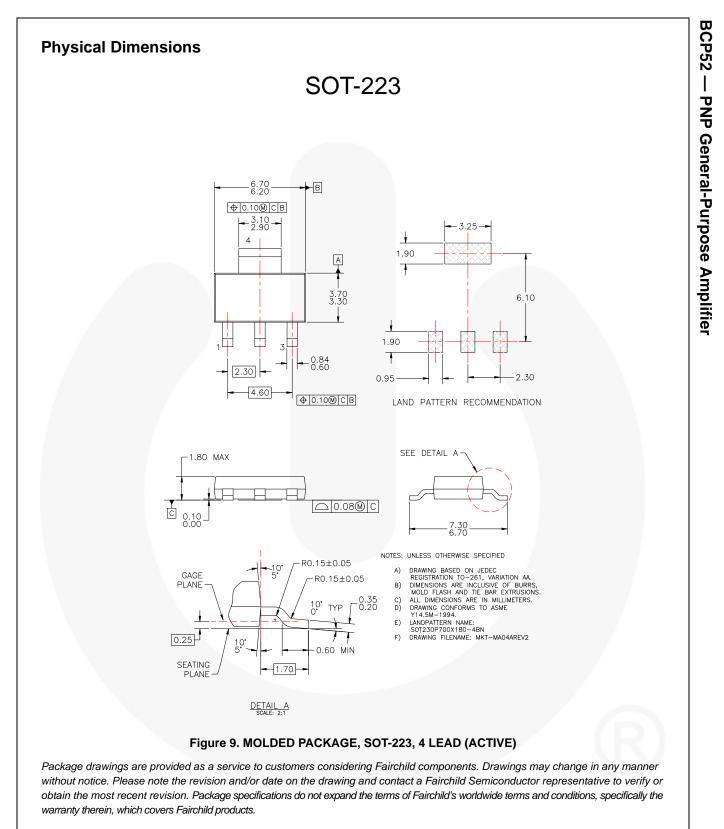


Figure 8. Power Dissipation vs. Ambient Temperature
