




# TOTAL POWER DISSIPATION vs. AMBIENT TEMPERATURE




# COLLECTOR CURRENT vs. BASE TO EMITTER VOLTAGE



# COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE




REVERSE TRANSFER CAPACITANCE


COLLECTOR CURRENT vs. BASE TO EMITTER VOLTAGE


