

The TLP512 consists of a high-output infrared emitting diode and a highspeed detector that contains a PN photodiode and an amplifier transistor into a single chip.








#### **Test Circuit 1: Switching Time Test Circuit**




#### **Test Circuit 2: Common Mode Noise Immunity Test Circuit**
