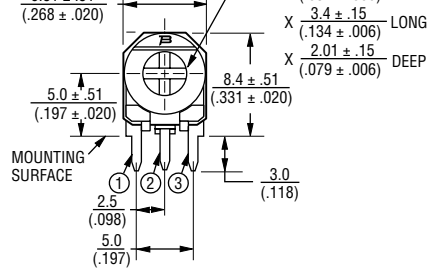


SUGGESTED PWB LAYOUT - STYLE F

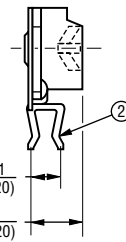
