





Relative Intensity Vs. Wavelength










CIRCUIT DESIGN NOTES


- 1.Protective current—limiting resistors may be necessary to operate the Displays.


Reflow Soldering Profile For Lead-free SMT Process.




- 1.We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C.
- 2.Don't cause stress to the epoxy resin while it is exposed to high temperature.
- 3. Number of reflow process shall be 2 times or less.

Reel Dimension




