General:

All recommendations according to the general technical specifications of the data sheet have to be complied with.

If the product is potted in customer applications, the potting material might shrink during and after hardening. The product is exposed to the pressure of the potting material with the effect that the core, wire and termination is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endangered to be affected. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.


Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

- The soldering profile has to be complied with according to the technical wave soldering specification, otherwise this will void the

- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't
 be ensured

- Strong forces and high accelerations of the components of the sizes 1014 and 8012 might have the effect of damaging the electrical
 connection or to harm the circuit board due to the heavy weight of the component. These damages will void the warranty.


