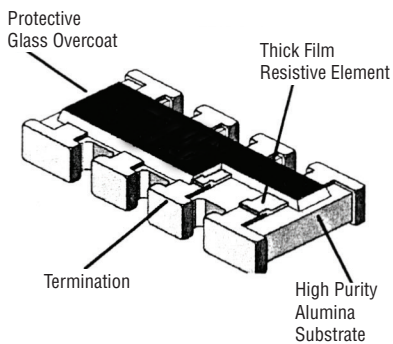

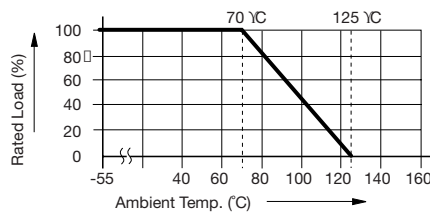

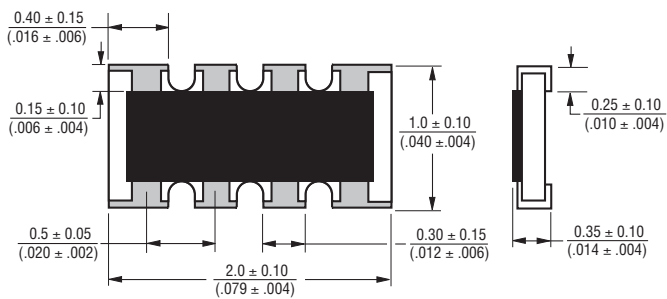

Soldering Profile for RoHS Compliant Chip Resistor Arrays

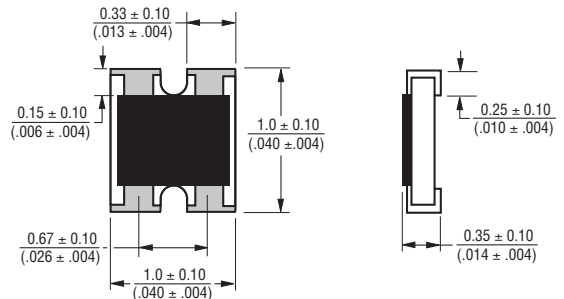

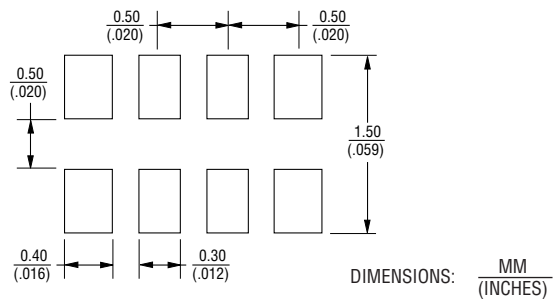


CAY10-xxxJ2

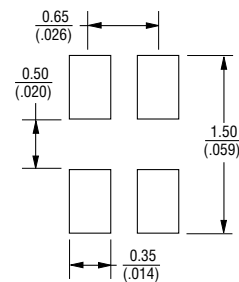


Land Pattern

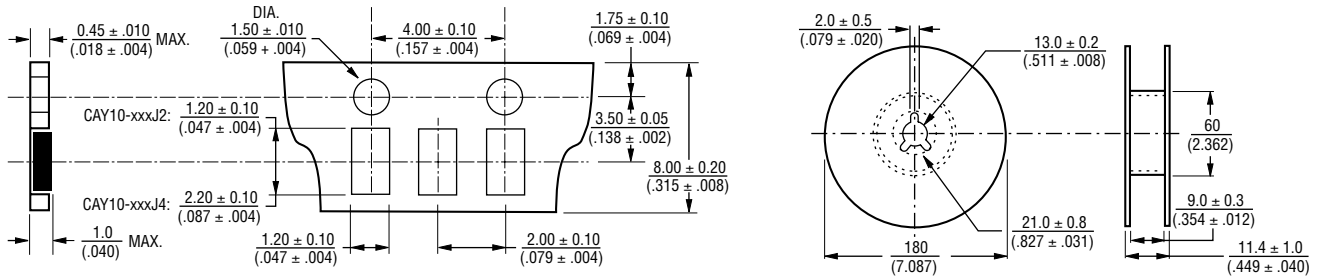
