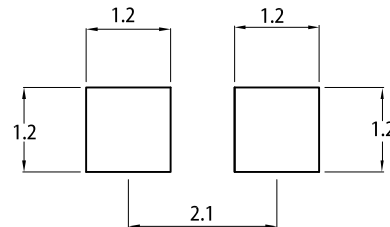

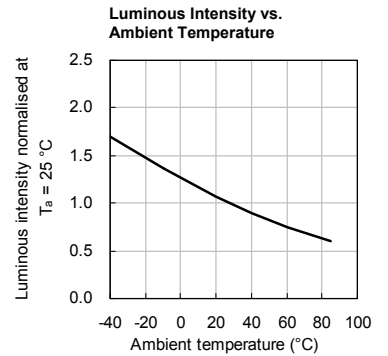
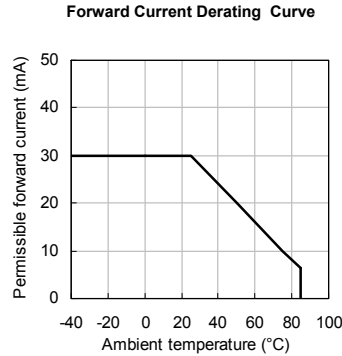
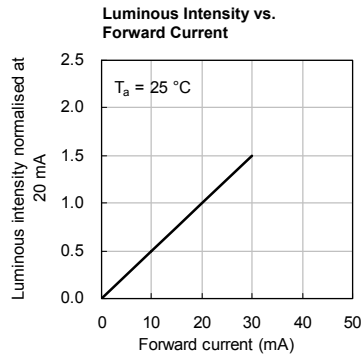
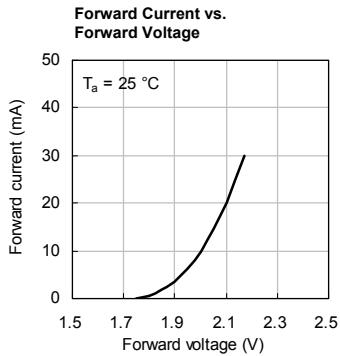
### RELATIVE INTENSITY vs. WAVELENGTH



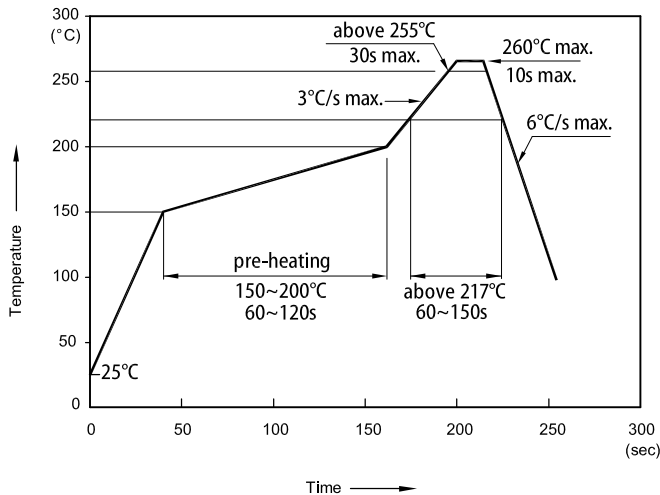
### SPATIAL DISTRIBUTION



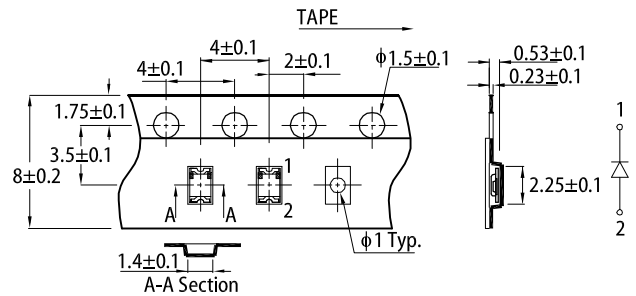

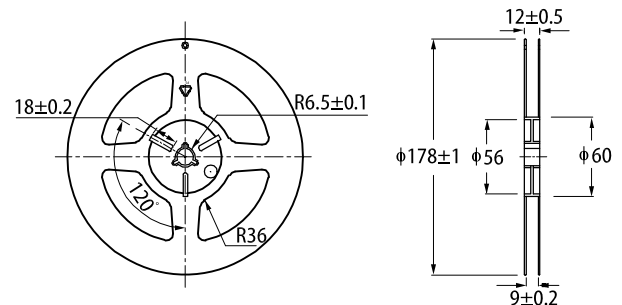
### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

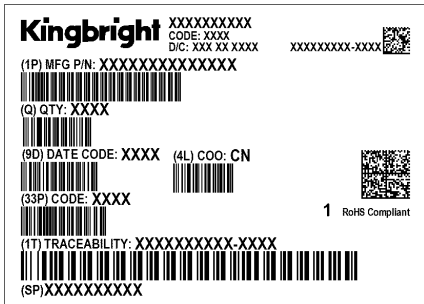
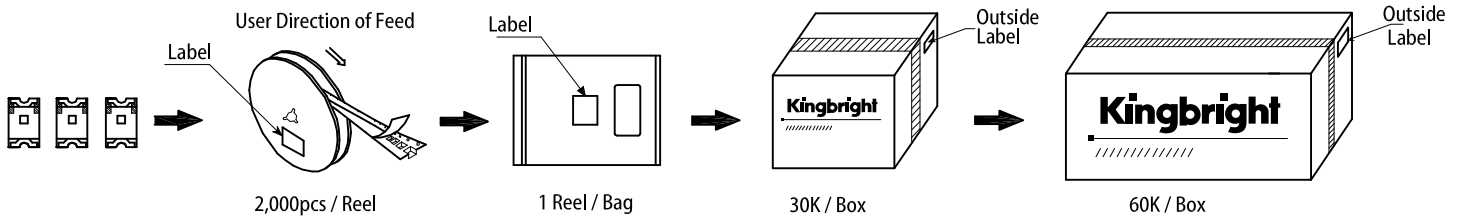


### REEL DIMENSION (units : mm)
