




Figure 1. On-Region Characteristics




Figure 3. On-Resistance Variation vs Drain Current and Gate Voltage




Figure 5. Capacitance Characteristics




Figure 2. Transfer Characteristics




Figure 4. Body Diode Forward Voltage Variation with Source Current and Temperature




Figure 6. Gate Charge Characteristics





Figure 7. Breakdown Voltage Variation vs Temperature




Figure 9-1. Maximum Safe Operating Area for FQP4N90C




Figure 9-2. Maximum Safe Operating Area for FQPF4N90C




Figure 10. Maximum Drain Current vs Case Temperature




Figure 11-1. Transient Thermal Response Curve for FQP4N90C




Figure 11-2. Transient Thermal Response Curve for FQPF4N90C

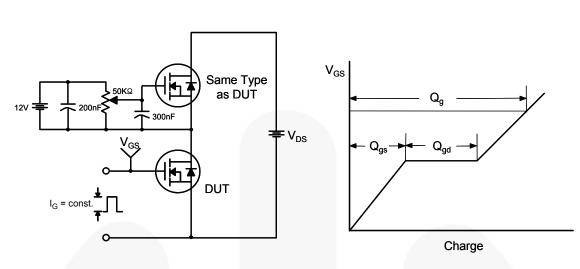


Figure 12. Gate Charge Test Circuit & Waveform




Figure 13. Resistive Switching Test Circuit & Waveforms





Figure 14. Unclamped Inductive Switching Test Circuit & Waveforms




Figure 16. TO220, Molded, 3-Lead, Jedec Variation AB

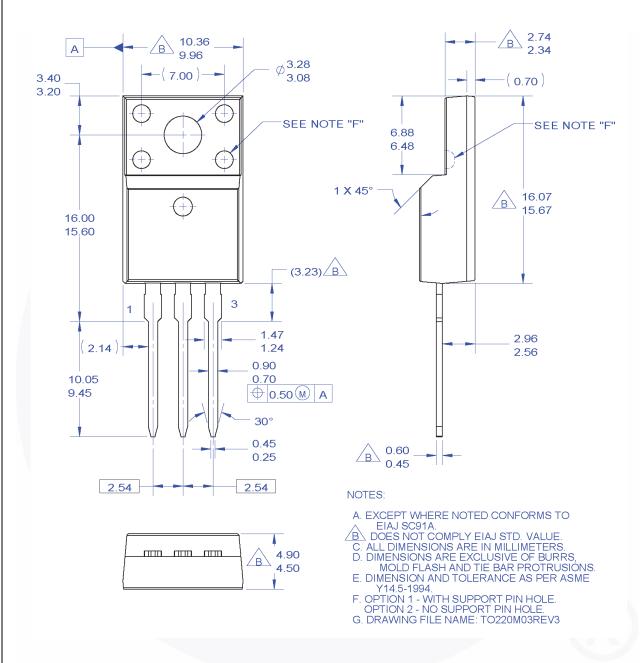


Figure 17. TO220, Molded, 3-Lead, Full Pack, EIAJ SC91, Straight Lead
