




VCE - Collector Emitter Voltage (V)


Safe Operating Area



Transient Thermal Impedance




Transient Thermal Impedance






VBE(sat) - (Volts)









I_c - Collector Current (mA) **hFE v Ic**






Ic - Collector Current (Amps)

VBE(sat) v IC






