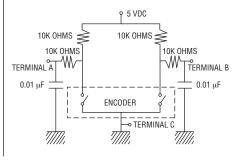






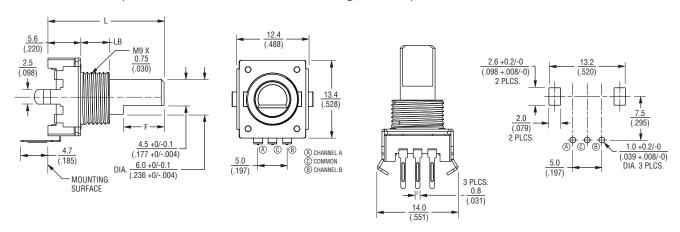


#### **Suggested Filter Circuit**

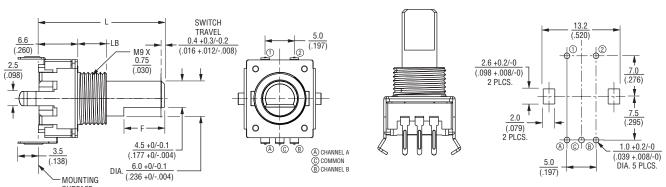

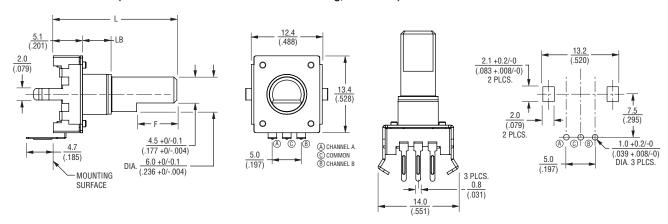

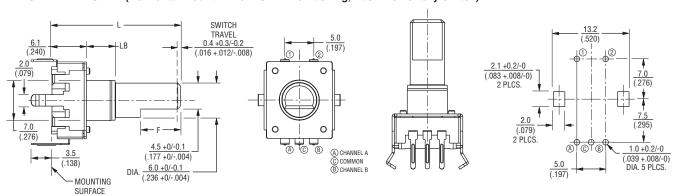
