






Fig.1 Forward Current vs. Forward Voltage



Forward Current : I_F [mA]







Fig.4 Ratio of Maximum Tolerable Peak Current vs. Pulse Duration





Fig.5 Ratio of Maximum Tolerable Peak Current vs. Pulse Duration
