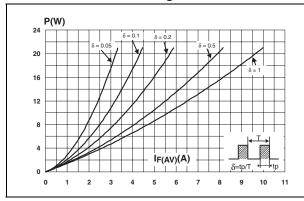

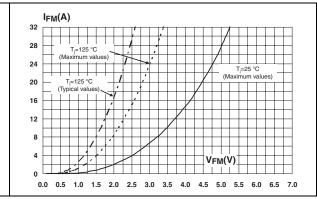
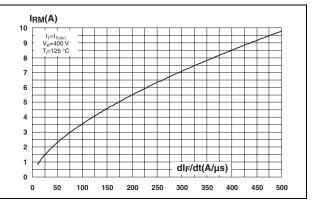


Figure 3. **Relative variation of thermal** impedance junction to case versus pulse duration

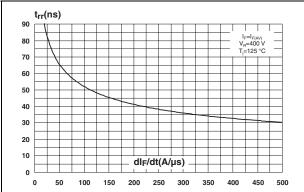

Figure 5. Reverse recovery time versus dl<sub>F</sub>/dt (typical values)


Figure 6. Reverse recovery charges versus dl<sub>F</sub>/dt (typical values)



Figure 8. Relative variations of dynamic parameters versus junction temperature







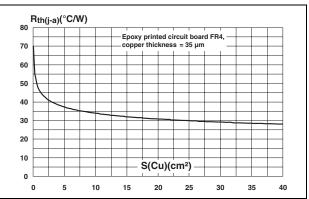

Figure 12. Thermal resistance junction to ambient versus copper surface under tab






