

LP8557EVM User Guide

1 Introduction

The LP8557EVM evaluation kit is ready to be used with a power source and a PWM input. The boost switching frequency and the maximum led current are set by resistors R3 and R4.

2 LP8557EVM Startup




Figure 1. LP8557 EVM Main Board

The LP8557EVM requires a power source and Pulse Width Modulated (PWM) input. See [Figure 1](#) for the connector descriptions and the location of the PWM input on the left side of the board.

1. Connect the LED board to the LP8557 evaluation board. Set jumpers for 6 LEDs per string as shown in [Figure 3](#).
2. Connect external power and ground to the board. Suggest 3.6V to VIN. VDD is not required if P2 is in place.
3. Connect Ground to GND jack.
4. Connect a pulse generator or PWM source to the PWM input. R2 is a 10 K Ω resistor to ground on this input.
5. Set pulse stream to 30 kHz frequency, 50% duty cycle, 3V input high level.
6. Turn on power supply.
7. Enable pulse stream output.

The LEDs will light at 50% brightness if a 50% duty cycle is used. The brightness will vary with the positive duty cycle of the PWM input signal.

3 Changing Boost Frequency and PWM Frequency on the LP8557EVM

The LP8557EVM is configured to operate at 500 kHz boost switching frequency and 9.8 kHz PWM frequency by the resistor R3 equal to zero ohms. This resistor can be changed to a value from Table 4 of the LP8557 datasheet which is presented here.

4 Changing Maximum Current on the LP8557EVM

The LP8557EVM is configured to operate at a maximum current of 20 milliamps as set by resistor R4 equal to zero ohms. This resistor can be changed to a value from Table 6 of the LP8557 datasheet which is presented here.

5.1 Main EVM Board

To use current sense resistors on the eval board, remove the jumpers and place 10 ohm resistors.




Figure 2. Current Sense Resistors




Figure 3. LED Loadboard




Figure 4. Kit Assembly




Figure 5. LP8557 EVM Schematic
